**The Corporate/Business/Organization Hall of Fame Award** recipient will be recognized for the contributions made to the community that have had a lasting effect on Boone County.

- The business/organization was/is a leader in the development of some outstanding aspect of our community.
- The business/organization provides valuable service to improve the quality of life for others in the community.
- The business/organization brought distinction to the community through state or national recognition of outstanding effort and/or development.

**The Living Hall of Fame Award** recipient is being recognized for their continued contribution to the enhancement of their self, their business, or their community during their professional life.

- The nominee demonstrated excellence, creativity, and/or initiated historic preservation initiatives for the community.
- The nominee provided valuable service to improve the quality of life for others in their community.
- The nominee values and participates in preserving Boone County's history.

- Nominations for the HALL OF FAME Awards must be submitted on this form.
- The nomination must be made by a member in good standing of the Boone County Historical Society.
- The information submitted should support the award criteria.
