- The nominee brought positive distinction upon themselves and the community through extraordinary achievements that brought statewide or national recognition.

The Business/Organization Hall of Fame Award nominee will be recognized for the contributions made to the community that have had a lasting effect on Boone County.

- The business or organization was or is a leader in the development of our community.
- The business or organization provides a valuable service that improves the quality of life for others in the community through its work, philanthropy and community service.
- The business or organization brought distinction to the community through extraordinary achievements that brought statewide or national recognition.

The Living Hall of Fame Award nominee will be recognized for their lasting contribution to the community through their professional or philanthropic life.

- The nominee demonstrated professional or philanthropic excellence, creativity, or initiative for the community that created a lasting and positive impact.
- The nominee provided valuable service to improve the quality of life for others in their community, either through their work, personal sacrifice, teaching or building.
- The nominee brought positive distinction upon themselves and the community through extraordinary achievements that brought statewide or national recognition.

- Nominations for the Hall of Fame must be submitted on this form.
- *The nomination must be made by a member in good standing of the Boone County Historical Society.*
- The information submitted should support the award criteria.
